The Samaritan House Kids' Shoes program would like to **thank The Alliance of Professional Women** and the **Outreach Committee** for your generous support of the back to school fall fundraiser.

New APW member, **JULIE IZARD**, and her family--husband, Pierre Izard, and their two daughters Tamsin (6) and Camille (3)-- started the Kids' Shoes program 6 years ago, and since then, through the generous support of their friends and family, have made it possible for over 200 kids to have new shoes for the beginning of the school year.

This year, the Outreach Committee decided to contribute \$500 to the program. With the APW contribution, the program raised a total of \$1,200 in funding, allowing for the purchase of shoes for 32 children. One of the single fathers was choosing shoes for his three year old, and he said "God Bless the Samaritan House, and God Bless all the people who helped these kids."

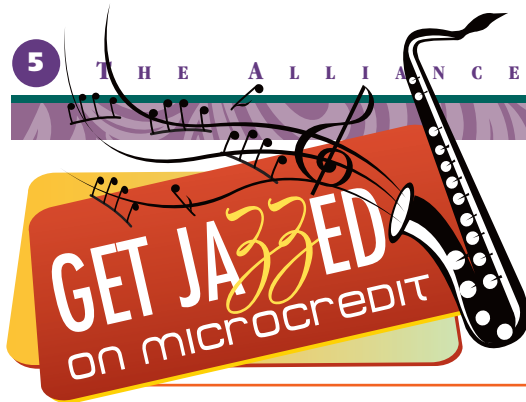

Amendment 62: Here We Go Again!

In 2008, one of the ballot measures that were defeated by the voters was Amendment 48 – a measure that would have defined a “person,” for purposes of the Colorado Constitution, as including “any human being from the moment of fertilization.”

Roll forward – in this 2010 election year, there will be Amendment 62, a ballot measure that would amend the Colorado Constitution to define the term “person” to include “any human being from the beginning of the biological development of that human being.”

The Amendment would apply this definition of “person” to the sections of the Colorado Constitution that protect the natural and essential rights of persons, allow open access to the courts to every person and ensure that no person has his or her life, liberty or property taken away without due process of law.

Amendment 62 raises all of the same concerns as were raised by Amendment 48 in 2008. It would have a significant impact on the laws of the State of Colorado and would present a number of unintended consequences that go far beyond pro-choice and pro-life arguments.

Examples of these unintended consequences include:

- The term “person” appears more than 20,000 times in Colorado statutes, as well as in Colorado regulations and municipal ordinances. To redefine the term “person” would effectively amend all of these statutes, regulations and ordinances. All case law that has developed in defining the term would need to be revisited. Every area of law would be impacted including criminal law, family law, elder law, tort law, health law, trusts and estates and business law.
- “Beginning of the biological development of a human being” is not defined. It might mean that any form of birth control that prevents implantation of a fertilized egg, such as an IUD, would be banned or illegal. It could also mean that a fertility clinic would be limited to fertilization of only one egg in order to avoid having to freeze embryos for future infertility procedures, thus increasing the costs of such procedures.
- A healthcare provider might be prevented from effectively treating high risk health conditions that occur during a pregnancy, such as cancer, preeclampsia, or tubal pregnancy, when the very real dilemma of the health of the mother versus the health of the fetus come into play.
