Target Date Mutual Funds: Are They Right For Me?

What is a Target Date Mutual Fund?

Gaining popularity recently, it's a tool that is designed to take the job of picking a diversified group of investments and monitoring the mix off your hands. It's a basket of different mutual funds that is managed to get more conservative as your retirement date draws near. Sound good? It can be for some investors.



The Good News: Target Date Funds let you pick your planned retirement date and the portfolio is pre-designed to meet that date. Diversification over many investment areas, including U.S. stocks, bonds, and international companies is done for you.

Professional management and rebalancing lets you set it and forget it - just like the old Ronco Chicken Rotisserie. You start with a more aggressive investment mix in your younger years and the fund automatically gets less risky as you get closer to your target retirement date.

The Bad News: Not all Target Date Funds are created equally. Stock allocations in a 2010 target fund vary from 30% to 70% depending on the fund family.

Also, the company managing the basket of mutual funds within the target date fund may choose to put new or under-performing funds into the mix as a way of increasing assets in those areas.

Generally, Target Date Funds can be a good answer when you have 10 or more years before retirement and you don't like to actively manage your own investments. However, as with any major purchase, it pays to look under the hood before buying.

Here are a couple of facts about South America:

- It's the fourth largest, the southern of the two continents of the Western Hemisphere.
- It is divided into 12 independent countries—Argentina, Bolivia, Brazil, Chile, Colombia, Ecuador, Guyana, Paraguay, Peru, Suriname, Uruguay, and Venezuela
