Speaker for APW's January Networking Luncheon

On August 1, 1999, **POLLY LETOFSKY** left her home in Vail and headed west. She traveled across four continents, 22 countries, and over 14,000 miles -- by foot — to become the first woman to walk around the world.

As an awareness campaign for breast cancer, survivors and well-wishers around the world came out to walk with her. Every day strangers welcomed her into their homes and shared meals.



Across four continents she had dinner conversations with poets, politicians, country singers, olive growers, pig farmers and the female bomb maker in Australia. The world had embraced her.



But in the middle of Polly's five-year journey, the world suddenly shifted on its axis when September 11 flung us all into a crossroads in world history.

Polly's GlobalWalk has been featured in over 2,000 newspapers, magazines, radio and television stations around the world including Good Housekeeping, CNN International, The CBS Early Show, NBC's Your Total Health, and Fine Living Channel's Radical Sabbatical. A documentary

Polly's GlobalWalk has recently been released by Newcastle Productions. Her book, *3mph: The Adventures of One Woman's Walk Around the World* has reached #1 on Amazon's Travel books, has just been awarded Best Memoir at the 2011 National IPPY Book Awards – (Independent Publishers Association).

Polly richly details her journey with humor and honest reflection, the good times and the hardships. Sometimes serious, sometimes funny, always inspirational, Polly's program personifies the spirit of commitment and perseverance that will compel you to conquer life's challenges -- one step at a time.

Cindy Rold on Guatemala, Friendship Bridge, and APW

- **Imagine** being a 23 year old widow with two children and no education. How do you support your family?
- **Imagine** walking three hours one way into the mountains to gather plants and other natural materials to make natural dyes. Then walking three hours back carrying those plants and materials on your head or back.



- **Imagine** having 5 children and wanting an education for them, but knowing that you can't afford the uniforms and supplies, so they will end up getting anywhere from 0-3 years of education just like you.
- **Imagine** cooking 3 meals a day over a wood burning stove in a smoky room with a blackened ceiling.
- **Imagine** wanting to stand out among all of the weavers and beadmakers in your village, so you decide to make shampoo to sell and you take a 2 year course to learn how to make it right.
- **Imagine** not being able to read or write and using your thumbprint instead of a signature when you get a loan or make a loan payment.

These are just some of the women I met on a **Friendship Bridges Insight trip** to Guatemala last February. They are among the 14,000 women who receive micro-credit loans from Friendship Bridge. Their lives are completely different than ours, and yet like us, they just want to make a living and create a better future for their children. Friendship Bridge, a non-profit based in Lakewood, makes that possible by providing small loans (typically \$300) to women so they can start businesses.

The women use the profits from their businesses to buy uniforms and school supplies so their children can attend school. They use the profits to buy food and clothing. They use the profits to create hope and a future for them, their husbands, and their children.

In addition to loans, Friendship Bridge provides education at every monthly meeting held by the borrowers on subjects chosen by the women. Most of these women have very little formal education, and they are grateful for any type of learning. When I visited Guatemala, I saw the women in one of the borrowing groups learn how to value themselves.

Cindy Rold on Guatemala, Friendship Bridge, and APW

What we take for granted in terms of self-esteem was a new concept for them.

I first learned about Friendship Bridge at APW's fundraiser at Dazzle Restaurant and Lounge last fall. We raised money to support one of Friendship Bridge's Village Banks. I became intrigued, went to their website, and learned about their Insight trips. In February, I joined a small group of 12 other women (and a couple of men) to visit Guatemala. We visited clients in their homes; attended monthly loan repayment meetings; visited clients' businesses; and attended a loan disbursement meeting. We also ate delicious food, enjoyed the culture, and learned something about Guatemala. I had never been to Guatemala and knew little about it. The trip allowed me to experience the country in a unique and fascinating way.




