# **Alliance Reservations** and Using BLACKTIE

The Alliance provides, as a service to its members, the ability to RSVP for events through BlackTie, an on-line reservation system. **Why use BlackTie? It saves The Alliance, literally, hundreds of dollars a year** in administrative costs when members use BlackTie to RSVP. Once you get the hang of it, you might also find that it's easier for you!

#### Here is a quick Blacktie tutorial note:

There are a few ways to access an event via Blacktie. Let's say, in this example, that I'm interested in RSVP'ing for the January Networking Luncheon.

I can either: Go to www.blacktie-colorado.com.

- a. Click on "Event Calendar" (top menu bar) Click on "Denver"
- b. Select "January" as the month on the calendar displayed.
- c. Find the date of the event.
- d. Click on the event.
- e. Select "Click Here to RSVP or for Online Tickets"
- **OR** Go right to the registration page by clicking on the links provided in every Communiqué or e-mail reminder about the event.
- **OR** Go to **www.apwcolorado.org** and register from the Event Details, this will take you right to Blacktie to complete your menu choice.

Either process will take you to a screen where you RSVP, enter your payment information (credit card) and select your entrée. Please note that Blacktie will not complete your transaction UNTIL you select an entrée, except when we are serving family style. If you have food allergies, you have the ability to enter them here, so we can alert the restaurant before you arrive at the event.


If you like/need to have receipts for tax time, Blacktie has a pop-up window that should appear after completing your transaction that displays your receipt for printing.


Our online registration is generally cut-off at 5pm the Monday, before our Thursday luncheons (usually on the 2nd Thursday of each month) to provide our restaurant guarantee. After this time, there is a \$5 late fee accessed.




