

Shere Chamness – REALART

November Lunch Sponsor

I am entering my 27th year of creating my own career. What does this mean to you? Perhaps nothing... unless you wish you were on a different path.

In 1976, my sister-in-law arranged a "good job" for me in the large basement office of the Army - Air Force Exchange Service headquarters in Dallas. It paid TWICE the minimum wage of the day and I was supposed to feel lucky about it.

Trouble was, I was miserable. My sensitivity to tobacco smoke was irritated by 22 other women who smoked. Hard to believe, but in 1976, people smoked cigarettes at their desks. I'll spare you the other wretched torments of that job.

One day I said to myself: there has to be a way to make a living doing things I enjoy. I inventoried my skills and asked, what do I need to change to get the reality I want? I always wanted to be an artist, but I had no idea how to accomplish this. I made up my mind: I would not quit until I became a REAL artist.

First, I would have to return to college. For six months I saved my money religiously, then quit AAFES and enrolled in college. For the next two years, I held part-time minimum wage jobs while attending classes. I drove a bus, secretaried in a library, watered plants in a nursery, waited tables, tended bar: all skills I would later put to good use. But I was always a few dollars away from being evicted.

I met a successful commercial artist in Dallas and asked him to hire me as an apprentice. (Hey, it worked for the old masters!) He taught me how to work with clients in the real world as we produced the very first Tostito's logo for Frito Lay. After a year, I printed business cards for myself as a freelance artist. But this venture failed miserably and I was kicked out of my apartment. Friends took me in for a couple of weeks until I found a job at a silk-screen company. I did freelance jobs on the side, and quit the silk-screen job after one year to try again with art. Unfortunately, I still had not learned how to run a company, and I found myself destitute again.

In early 1982, I landed a job in a brand new advertising firm in Fort Worth Texas. I created ads by day and paintings by night and on weekends. I saved up money while analyzing what had gone wrong in my two previous attempts at freelancing. I realized I needed better bookkeeping and marketing skills. But how to learn those?

Suddenly I slapped myself on the proverbial forehead: I worked in a new advertising agency! And it lacked the same elements as me. For four years, I implemented new ways to move projects



through the organization and created a method for keeping track of employee hours and expenses. I taught myself the missing skills, while improving the company's procedures.

On December 17, 1985, with \$969 in the bank, I quit the ad agency and formed REALART. Within a week, I had doubled my income, and within a year, I was a respected freelance artist, doing projects I loved for people I enjoyed. Every day there were new opportunities: murals, logos, brochures, catalogs, magazines, photo retouch, and all the painting and drawing I could handle.

But this is not the end of the story. In 1996, I created a website for myself. A restaurant asked me to do one for them. Then several other new clients wanted websites. In a short time, REALART morphed into WWW.PLANET-REALART.COM. And that's still not the end of the story. Last fall I created yet another unique profession. Using my website skills, I built www.CozmicSeeds.com, for selling gemstone necklaces based on a person's horoscope. It's been a very satisfying path for me, this little career of mine. Who knows where it will take me next?

If you are trying to change your path, ask yourself these questions.

- What activities do you enjoy doing?
- Who would pay you to do this?
- What do you need to change to get the reality you want?
- What small or large action can you take right now to move in that direction?

May you find your own fulfilling path, doing things you enjoy!

Samaritan House – Kids' Shoes Campaign Thanks APW!



Dear Dana, To Button or Not to Button (Your Jackets)



*Is it better to button my jackets or leave them undone?
I'm never really sure how they should fit either.*


Dear Button Baffled,

TLC's What Not to Wear hosts, Stacy London and Clinton Kelly, insist you should always be able to button your jackets. While I love Stacy and Clinton, I completely disagree! I never button my jackets...ever! It's not my personal style, nor do I like the uber-constricting way it feels.

Buttoning your jacket positions you as slightly more formal. It can be useful in extremely traditional, formal situations like government and high powered business dealings. I personally feel that especially in Colorado's casual climate, leaving your jacket undone will not hurt your credibility or authority; however if you're more comfortable with your jacket closed, it is perfectly fine, too.

Typically a size 8 jacket fits me well. Because I have a wide torso and back, if I wanted to button my jacket, I would need to purchase a size 10 and have many costly alterations made. It doesn't make sense to do this, as I'm not a buttoner.

Are you a buttoner or a non-buttoner? When I work with clients, I always like to find out if they prefer to button their jackets or leave them open, as it will many times determine our choices. Whether you're a buttoner, a part-time buttoner, or a non-buttoner, here are a few considerations:



- If you button your jackets, even part-time, you should never have any pulling across your back or at the buttons. When pulling occurs, you will need to buy a size larger and have the jacket tailored to your body with the buttons closed.
- When a jacket is only a tiny bit too tight when buttoned, you can potentially move the button a bit to make the jacket fit properly. Be sure to consult with a good tailor so as not to compromise the quality look of the jacket.
- Jacket style is also important. If you're a non-buttoner like me, you may want to avoid jackets with princess seams. The curved seams provide you with a beautiful fit over your bustline when buttoned, but when left open, the jacket may hang too loosely, appearing overly large and sloppy.
- Conversely, you must ensure your jackets don't look a little skimpy when left unbuttoned. The center front line created by the jacket opening shouldn't be too wide. The jacket should lie smoothly over your bust.

As always, I urge you to try clothes on in the fitting room. Experiment with sizes to get a good fit, and keep in mind alterations may be necessary for a perfect fit.
