Amendment 48: Simple but So-o-o Far Reaching!

Amendment 48 is a proposed amendment to the Colorado Constitution that would define the term “person” to include “any human being from the moment of fertilization.”

It would apply this definition of “person” to the sections of the Colorado Constitution that protect the natural and essential rights of persons, allow open access to courts to every person and ensure that no person has his or her life, liberty or property taken away without due process of law.

The Alliance of Professional Women was asked to take a position in opposition to Amendment 48 by a number of its membership. The APW takes positions only after thorough review of both sides of an issue and a vote of its board of directors. In addition, it only takes positions that do not conflict with the opinions expressed by the membership in the biennial survey conducted by the Public Affairs Committee. After review, The Alliance of Professional Women has determined to oppose Amendment 48 because it is a Constitutional amendment that will significantly impact the laws of the State of Colorado and will present a number of unintended consequences that go far beyond pro-choice and pro-life arguments. Examples of these unintended consequences include:

- The term “person” appears more than 20,000 times in Colorado statutes, as well as in Colorado regulations and municipal ordinances. To redefine the term “person” would effectively amend all of these statutes, regulations and ordinances. All case law that has developed in defining the term would need to be revisited. Every area of law would be impacted including criminal law, family law, elder law, tort law, health law, trusts and estates and business law.
- “Moment of fertilization” is not defined. Amendment 48 might mean that any form of birth control that prevents implantation of a fertilized egg, such as an IUD, would be banned or illegal. It could also mean that a fertility clinic would be limited to fertilization of only one egg in order to avoid having to freeze embryos for future infertility procedures, thus increasing the costs of such procedures.
- Amendment 48 might prevent a health care provider from effectively treating high risk health conditions that occur during a pregnancy, such as cancer, preeclampsia, tubal pregnancy, when the very real dilemma of the health of the mother versus the health of the fetus come into play.

The Alliance of Professional Women urges you to vote “NO” on Amendment 48!

Public Affairs Update

On **September 16**, the APW Public Affairs Committee welcomed **ALAN PHILP**, representative of **A Better Colorado**, who provided facts about **Amendment 47**, the so-called "Right to Work" amendment. Amendment 47 asks voters to decide whether workers will be free to choose whether to join a union and pay union dues when taking a job at a unionized business site. Currently, if a business site is a "closed shop," all workers must join the union and pay dues as a condition of employment. Amendment 47 removes this requirement. Mr. Philp emphasized that the constitutional change brought by this Amendment will not take away the right of workers to organize a union or the right to collective bargaining. It does allow workers the right to say no to a union if, among other reasons, they do not agree on how union dues are being spent, e.g., on political activities that vary from workers' beliefs. Mr. Philp acknowledged the argument that this Amendment would allow those not joining the union to benefit from the union's activities at the business site, without contributing towards the cost of those activities. Nonetheless, Mr. Philp countered that states that have adopted the "right to work" laws have seen an increase in economic productivity and job growth.

Whatever your position on Amendment 47, remember to **vote on November 4, 2008!**

You're right, the fashion industry has decided it's time for new necklines, and they're not flattering for everyone.
