



# The Alliance Foundation – Just The Facts Please!

We are all very excited about our 5th Annual Helping Women + Changing Lives Luncheon **on Thursday, September 8, at the PPA Events Center.** As we get ready for the luncheon, we want to pause and highlight some remarkable facts about what this special event has accomplished over just the past four years:

- Exposure: A combined total of over 1,400 people have attended the previous four luncheons.
- Financial Contributions: Sponsors and individual donations at the four previous luncheons have supported village banks, scholarships, and outreach activities to the tune of over \$200,000.
- Expanded Networks: If every person met one additional person, our networks have expanded fourfold.
- Awareness: Increased awareness to the issues, increased support for the issues.
- Leadership Skills: Table Captains have developed leadership skills as ambassadors for the Alliance Foundation.

Our 5th Annual fundraising luncheon is shaping up to be our best yet with incredible networking, inspiring stories and your chance to help make a difference in the lives of women and children in our community and around the world. Before this not-to-be-missed event, we want to make sure you understand how you are making a difference by supporting the Alliance Foundation.

#### Learn more with Lorni and Karen's Q&A

- Q: What programs does The Alliance Foundation support?
- A: We have three ways we help women in need:
  - Scholarships for women heading back for their junior and senior years in college. This is the time when many women hit the wall by trying to balance their work and family lives, causing many to think about giving up. Our scholarships help provide that important light at the end of the tunnel and help them to the finish line.
  - Village banks for women who live on less than \$2 per day. Based on a peer-lending model, our Village Banks program lends between \$100 and \$300 to a woman in a developing country. Women use these loans to start small businesses that allow them to take care of their families.
  - Outreach programs in our community. Many women experience homelessness, the need for help overcoming an addiction, or find that they can't afford presents for their children at the holidays. Our outreach programs support women and children in our community as they work hard to get back on their feet.
- Q: What is the size of a scholarship award?
- A: We currently support three women every year as they work toward their college degree, with a \$3,000 scholarship for each woman for two years, for a total of \$6,000.

- Q: What are the criteria for The Alliance scholarship?
  - (a) Woman
  - (b) Junior
  - (c) Nontraditional student
  - (d) Demonstrated academic aptitude
  - (e) Financial need
- A: All of the above.
- Q: How many Village Banks has The Alliance Foundation supported?
- **A:** The Alliance Foundation has opened 20 village banks in 9 countries. That's over 500 women who have received a small micro-loan to help them start or expand a business. And wait, there's more...once the loans are paid back, the Village Bank re-lends the money to another recipient in the community. This means that literally thousands of women have continued to receive these small business loans since our program started.
- Q: Can you name a couple of the organizations that the Outreach Committee supported last year?
- A: We supported Delores Project, a homeless shelter for women and Arapahoe House, which helps women overcome substance abuse.

# **Public Affairs** Meetings

The Public Affairs Committee is back from the summer break; relaxed, refreshed, and ready to offer new and exciting programs.

In **September, the Public Affairs Committee** will dig back into **addressing and discussing current events** at its **Tuesday**, **September 13** meeting. The speaker will be a representative from **9to5Colorado** who will discuss the upcoming Colorado ballot initiative that seeks to raise the minimum wage. This initiative will appear on this November's ballot. The initiative provides that Colorado's minimum wage would rise to \$9.30 per hour on the first day of 2017, and then would increase by 90 cents a year until it reaches \$12.00 per hour in the year 2020. After, that, the minimum wage would be adjusted every year based on the Consumer Price Index. There is some controversy about the initiative, some businesses are in opposition and others support it as a proposition whose time has come. Join us on September 13 to learn more about this important issue.

The **October Public Affairs Committee meeting** will be held on **Tuesday**, **October 11**. The speaker will be our very own **DEB ARMBRUSTER**, who will talk about all the other numerous ballot initiatives appearing on the November ballot. Deb is a retired attorney and an active member of the League of Women Voters. She receives training from the League about the initiatives' content and their pros and cons and then passes this information on to Public Affairs Committee attendees. This should be a very helpful and substantive meeting.

The Public Affairs Committee meetings are held at Zaidy's Restaurant, 121 Adams Street, in Cherry Creek. Meetings start at 7:00 am for networking, and then at 7:30 am our speaker begins the presentation. Meetings usually end by 8:30 am. Members eat while listening to the speaker, and the format is casual. Attendees buy their own breakfast.




